## **ADDITIONAL INFORMATION**

Tax status: Interest is paid gross without deduction of income tax. You will need to declare any income from savings interest earned over your PSA<sup>2</sup> through a self-assessment tax return to HM Revenue & Customs. Interest is paid on 31 January and available from the following day.
