HOW DO I OPEN AND MANAGE MY ACCOUNT?	- This account is available to new and existing customers - The Branch Saver is a traditional passbook-based account and can only be applied for in person at our Epsom branch. The passbook is required for all transactions - A minimum of £1 must be deposited - Additions are allowed but not required on a regular basis - Additions to the account can be made by transfer from your bank account, by cheque, by transfer from another savings account or by cash - A maximum of £1,000,000 can be deposited in the account - Instructions for the account can only be made via our Epsom branch.		
CAN I WITHDRAW MONEY?	- Withdrawals are only available at our Epsom branch, without notice or access charge, and can be made by bank transfer, by transfer to another savings account with us, by cheque or by cash - Please see the ‘Taking money out’ section of the Product Features leaflet for full information.		

ADDITIONAL INFORMATION

TAX STATUS: Interest is paid gross without deduction of income tax. You will need to declare any income from savings interest earned over your PSA² through a self-assessment tax return to HM Revenue & Customs. Interest is paid annually on 31 January and available from the following day.

This issue may be withdrawn at any time without prior notice.

¹ AER stands for Annual Equivalent Rate and illustrates what the annual rate would be if interest was compounded.

²PSA stands for Personal Savings Allowance.
