CAN I WITHDRAW MONEY?	<ul style="list-style-type: none"> Withdrawals are only available at our Epsom branch, without notice or access charge, and can be made by bank transfer, by transfer to another savings account with us, by cheque or by cash Please see the 'Taking money out' section of the Product Features leaflet for full information. 	

ADDITIONAL INFORMATION

TAX STATUS: Interest is paid gross without deduction of income tax. You will need to declare any income from savings interest earned over your PSA² through a self-assessment tax return to HM Revenue & Customs. Interest is paid annually on 31 January and available from the following day.
